#### Glossary

Beta is a measure of the volatility of a portfolio relative to the overall market. P/E ratio of a stock is calculated by dividing the current price of the stock by its forecasted 12 months' earnings per share. The average of the price/earnings ratio of a fund is a weighted harmonic average of all the current P/E ratios (excluding negatives) of the stocks in the Fund's portfolio. Standard deviation is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. Turnover ratio is calculated by dividing the lesser of purchases or sales by the average value of portfolio assets during a period. Turnover is based on the portfolio's fiscal year end and is not annualized if the reporting period covers less than 12 months. Weighted average market capitalization is the portfolio-weighted mean capitalizations of all equity securities.
