

A higher R² indicates more of the portfolio's performance is affected by market movements and vice versa. Standard Deviation measures historical volatility. Higher standard deviation implies greater volatility. Sharpe Ratio measures riskadjusted performance using excess returns versus the "risk-free" rate and the volatility of those returns. A higher ratio means better return per unit of risk. Active Share represents the portion of portfolio holdings that differ from an index. Turnover is a measure of portfolio trading activity. Higher turnover may indicate higher transaction costs and vice versa.
