The Fund does not seek to achieve its stated investment objective over a period of time greater than a single day.

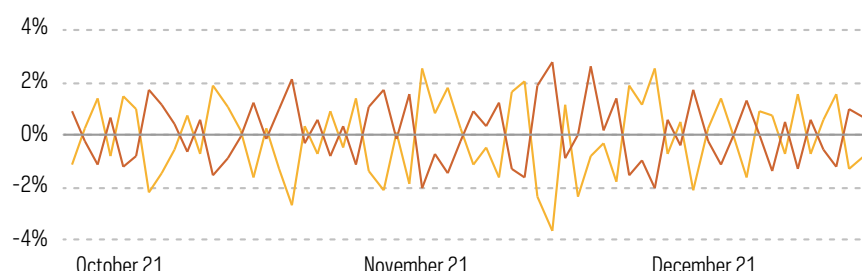
