- Includes approximately 2,200 holdings in nearly 50 countries.

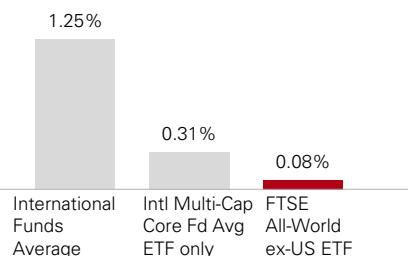
