The investment objective of the U.S. Sustainability Core 1 Portfolio is to achieve long-term capital appreciation.

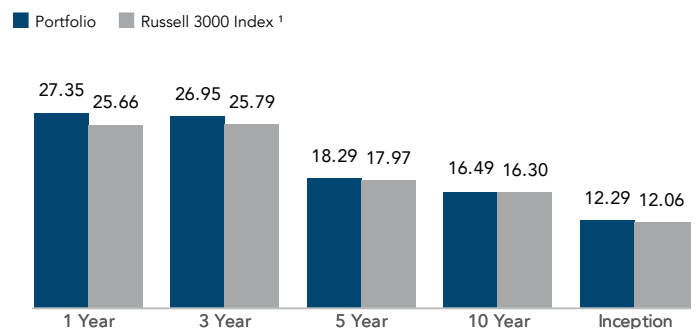
