The investment objective of the U.S. Social Core Equity 2 Portfolio is to achieve long-term capital appreciation.

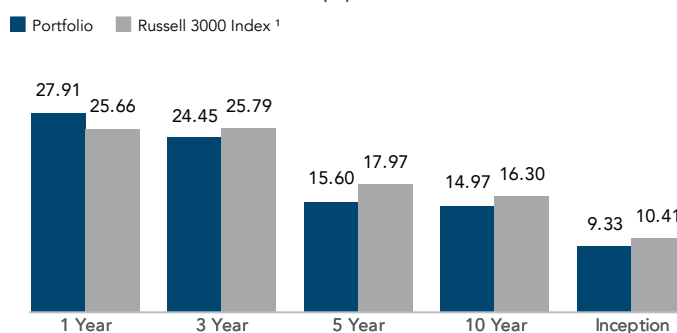
