Fund description


The Invesco S&P MidCap 400 Revenue ETF (Fund) is based on the S&P MidCap 400[®] Revenue-Weighted Index (Index). The Fund will invest at least 90% of its total assets in securities of midcapitalization companies in the Index. The Index is constructed using a rules-based approach that reweights securities of the S&P MidCap 400[®] Index according to the revenue earned by the companies, with a maximum 5% per company weighting. The Fund and Index are rebalanced quarterly.


