## Investment approach

- Seeks to track the performance of the MSCI US Investable Market Communication Services 25/50 Index.
- Multicapitalization equity in the communication services sector.
- The fund employs a passively managed, full-replication strategy when possible.
- If regulatory constraints prevent full replication, the fund uses a sampling strategy to approximate the index's key characteristics.
- The fund remains fully invested.
- Low expenses minimize net tracking error.

## About the benchmark

- The MSCI US Investable Market Communication Services 25/50 Index includes stocks of U.S. companies within the communication services sector.
- The sector is made up of companies that provide communications services primarily through fixed-line, cellular, wireless, high-bandwidth, and/or fiber-optic cable networks.
- Uses GICS methodology and clearly classified sectors.
- Offers broad representation of the target sector across large-, medium-, and small-cap companies.


