- It includes those Russell 1000 companies with lower price-to-book ratios and lower expected and historical growth rates.

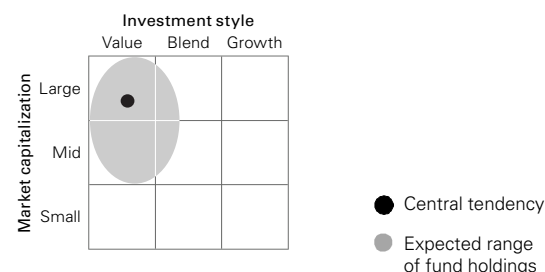

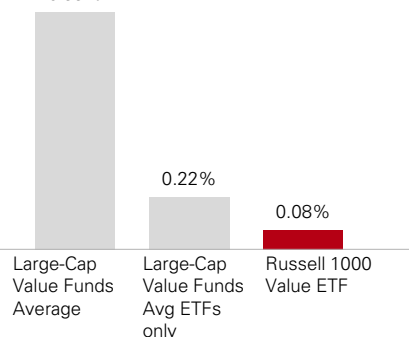
