It is a "subsidized" yield, which means it includes contractual expense reimbursements and it would be lower without those reimbursements. The 30-Day SEC Unsubsidized Yield calculation is also computed under the same SEC standardized formula based on net income earned over the past 30 days, but excludes contractual expense reimbursements, resulting in a lower yield.
