The fund's goal is to track as closely as possible, before fees and expenses, the total return of the Schwab 1000 Index®.

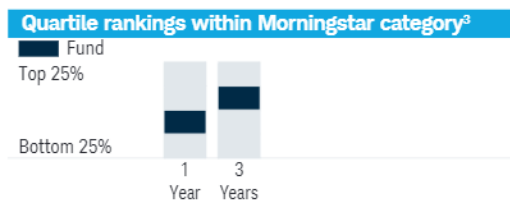

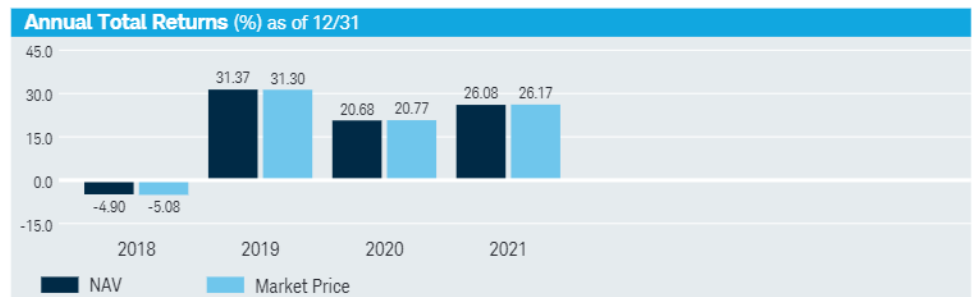

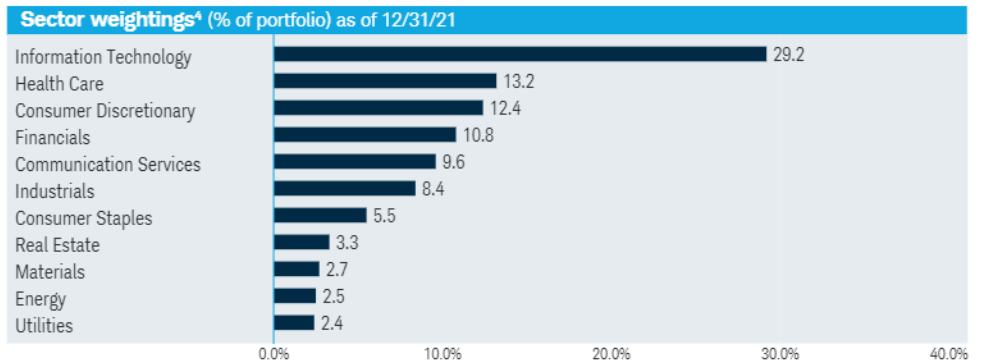
