U.S. LARGE-CAP VALUE

Stocks bought at a meaningful discount to business value may offer an inherent margin of safety1 and return potential. The Fund uses a bottom-up, fundamental approach to identify companies creating shareholder value through sustainable free cash flow generation. Combining this approach with a focus on quality, growing companies with strong balance sheets should reduce downside risk.

Highest-conviction ideas with clearly defined sell discipline. Prior to purchase, stocks receive upside and downside price targets. Stocks exceeding the upside price target may be sold, while those exceeding the downside price target typically undergo a review to validate the initial investment criteria. To manage risk, the Fund limits the maximum weightings of individual securities and sectors.

Brown Advisory partners with similarly minded investment managers. We seek managers with sophisticated and disciplined research teams generating bottom-up, fundamental research. We favor long-term approaches that are rooted in high conviction and low turnover.
