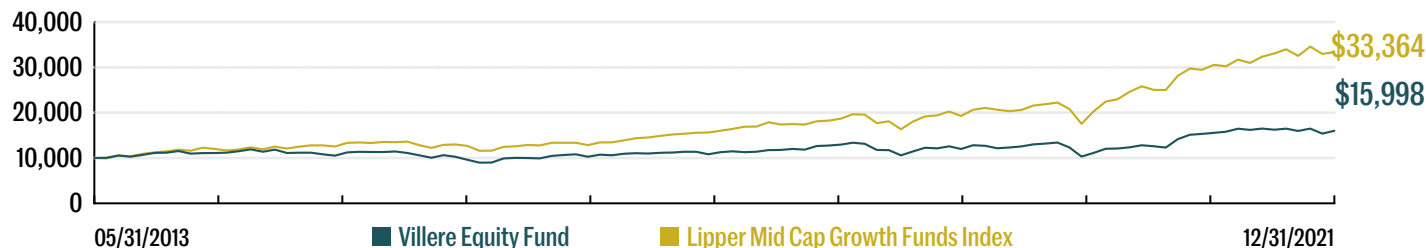

P/E ratio is a company's current stock price divided by its estimated next 12-months' earnings per share. **Market Cap** is the market price of an entire company, calculated by multiplying the number of shares outstanding by the price per share. **Turnover Ratio** is a measure of the fund's trading activity that is computed by taking the lesser of purchases or sales (excluding all securities with maturities of less than one year) and dividing by average monthly assets. **The Lipper Mid-Cap Growth Funds Index** is an unmanaged, equally weighted performance index of the 30 largest qualifying mutual funds (based on net assets) in the Lipper Mid-Cap classification. **S&P 500** is an unmanaged index which is widely regarded as the standard for measuring large-cap U.S. stock market performance.
