Enterprise Solutions	Companies that provide scalable technology solutions focused on disrupting traditional areas of financial services such as lending, credit scoring and banking.
Crowd-Funding	Companies that provide online platforms for sourcing funds from individual members.
Blockchain and Alternative Currency Developers	Companies that are involved in the development of blockchain technology, or that utilize blockchain technology to provide financial services. Sharpe Ratio	Measures the return for each unit of risk. The risk free rate is subtracted from the mean return and is divided by the standard deviation of returns.
