



Morningstar Style Map[™] As of 12/31/21

The Ownership Zone is derived by plotting each stock in the portfolio within the proprietary Morningstar Style Box. Over time, the shape and location of a fund's ownership zone may vary.

1. Royce dassifies a dient account as 'Core' because it anticipates the client account equity holdings will have a weighted average price-to-book ratio or weighted average normalized price-to-earnings ratio that is similar to, or somewhat higher than, its general asset dass. **2. Geometric Average.** This weighted calculation uses each portfolio holding's market cap in a way designed to not skew the effect of very large or small holdings; instead, it aims to better identify the portfolio's center, which Royce believes offers a more accurate measure of average market cap than a simple mean or median. **3. Below Average Volatility.** The Fund was in the second-lowest volatility quintile compared with all funds in Morningstar's Small Growth, Small Blend, and Small Value Categories with at least five years of history, a total of 499 funds as of 3/31/22. The universe consists of each fund's oldest share class only. Volatility quintiles are based on the average fund-every large to each of the last four calendar quarters. Harmonic Average.** This weighted calculation evaluates a portfolio as if twere a single stock and measures it overall. 

The Fund outperformed the Russell 2000 during 12 out of 14 downturns of 15% or more from the index's prior historical high since the index's inception.






Long-Term Risk/Return Profile

Market Cycle¹ Performance (%)



The **Morningstar Style Map** uses proprietary scores of a stock's value and growth characteristics to determine its placement in one of the five categories listed on the horizontal axis. These characteristics are then compared to those of other stocks within the same market capitalization band. Each is scored from zero to 100 for both value and growth attributes. The value score is subtracted from the growth score to determine the overall style score. For the vertical, market cap axis, Morningstar subdivides into size groups. Giant-cap stocks are defined as those that account for the top 40% of the capitalization of each style zone; large-cap stocks represent the next 30%, imit-cap stocks the next 20%; small-cap stocks the next 20%; small-cap totaks reprised by measuring the Fund's benchmark (Russell 2000). It is calculated by dividing a company's share price by its trailing 12-month earnings-per-share (EPS). **The Price-to-Book**, or P/B, Ratio is calculated by dividing a company's share price by its book value per share. **Standard deviation** is a statistical measure within which a client account's total returns have varied over time.
