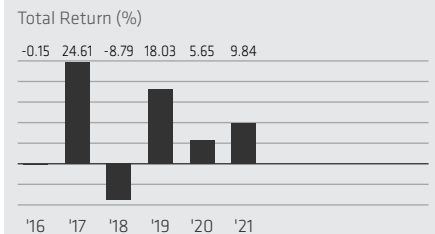

A WORD ABOUT RISK
