

EPS Growth Rate is the projected growth rate in earnings per share for the next five years. Price/Book is the ratio of a stock's price to its book value per share. Price/Earnings is the ratio of a stock's price to its earnings per share. Return on Equity is the average amount of net income returned as a percentage of shareholder's equity over the past five years. R Squared represents the percentage of the portfolio's movement that can be explained by the market. Standard Deviation measures the portfolio's total-return volatility. A higher standard deviation indicates greater historical volatility. Turnover is a percentage of a portfolio's assets that have changed over the course of a year. It is calculated by dividing the average assets during the period by the lesser of the value of purchases or the value of sales during the same period.
