- Maximum sector exposure is 30%


#### **Market Capitalization**

The top 10% of products in each product category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star. Analyst Rating: As of 31 Mar 2022 there were 1 gold rated, 11 silver rated, 15 bronze rated, 6 neutral rated and 108 not rated funds in the Mid-Cap Value category based on the cheapest share class for each fund as defined by Morningstar. Active Share measures the difference between portfolio holdings and the benchmark. The higher the active share, the greater the risk. Relative to the Russell 2500 Index. Standard Deviation measures the volatility of a portfolio's returns. Beta measures a portfolio's sensitivity to market movements. Sharpe Ratio is the measure of risk-adjusted return of an investment portfolio. Alpha is the excess return of an investment relative to the index's return. R-squared represents the percentage of a portfolio's movements that can be explained by general market movements. Up/Down Capture Ratio is used to evaluate how well a portfolio performed relative to an index during periods when that index has risen/dropped. Statistics for periods less than one year are not annualized.
