The investment objective of the U.S. High Relative Profitability Portfolio is to achieve long-term capital appreciation.

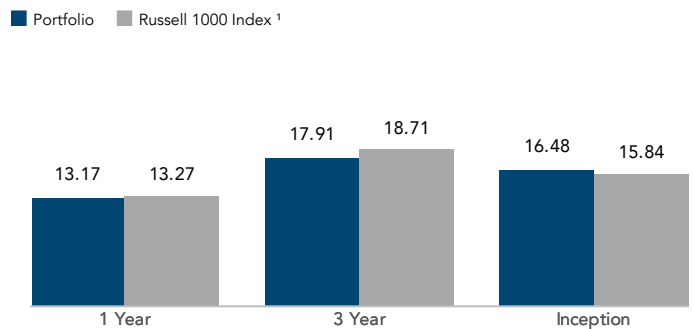
