The investment objective of the U.S. Large Cap Growth Portfolio is to achieve long-term capital appreciation.

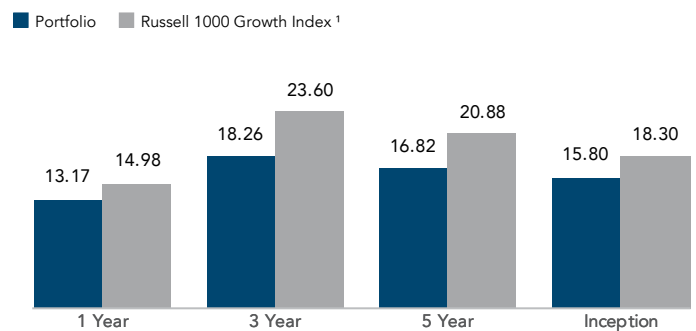
