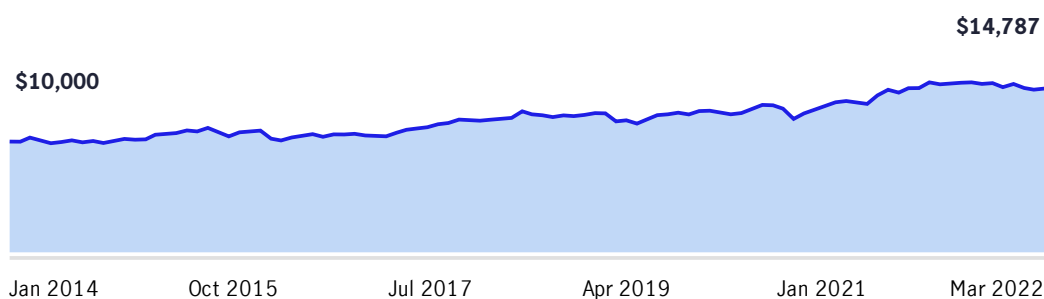

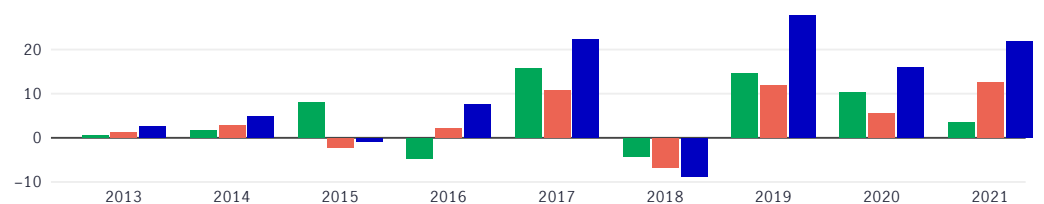

Class I without sales charge – 1/1/14 – 3/31/22

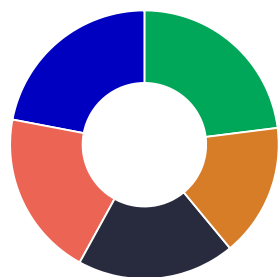

**Calendar year returns<sup>4,5</sup>**

A higher Sharpe ratio suggests better risk-adjusted performance. **10** Standard deviation is a statistical measure of the historic volatility of a portfolio. It measures the fluctuation of a fund's periodic returns from the mean or average. The larger the deviation, the larger the standard deviation and the higher the risk. **11** Upside capture ratio measures a manager's performance in up markets relative to the market itself. Downside capture ratio measures a manager's performance in down markets relative to the market itself. **12** Listed holdings reflect the largest portions of the fund's total and may change at any time.
