Objective: The fund's primary investment objective is to provide you with long-term growth of capital.

Distinguishing characteristics: Seeks to take advantage of evolving global trade patterns by predominantly investing in companies that have potential for growth in capital. 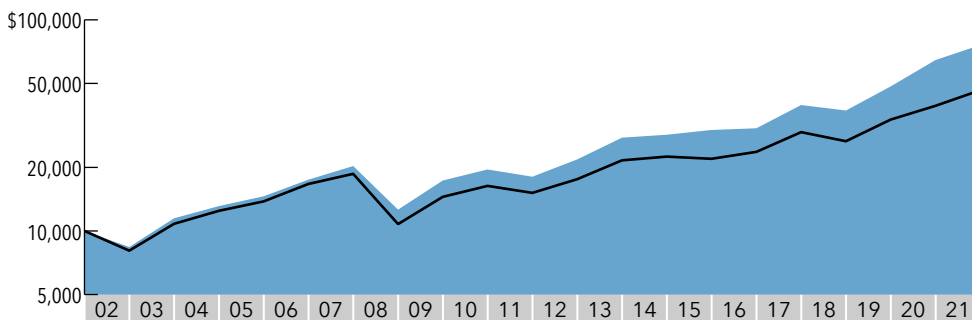
