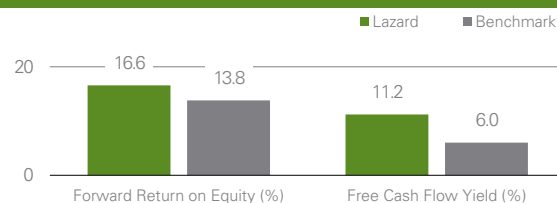

Definitions: Forward-looking figures represent next twelve months expected returns. The higher the Sharpe ratio for a portfolio, the better its risk-adjusted returns have been. **Active share** is a measure of the percentage of stock holdings in the portfolio that differs from the index.
