>> Index Description

- >> The Nasdaq US Smart Semiconductor Index is a modified factor weighted index created and administered by Nasdaq, Inc. ("Nasdaq") designed to provide exposure to US companies within the semiconductor industry.
- >> Nasdaq selects the 30 most liquid eligible semiconductor securities from the NASDAQ US Benchmark Index and then ranks those securities based on three factors:
 - Volatility – trailing 12-month price fluctuation.
 - Value – cash flow to price.
 - Growth – the 3-, 6-, 9-, and 12-month average price appreciation.
- >> The securities are weighted based on their score on the three factors.
- >> The index weighting methodology includes caps to prevent high concentrations among single stocks.
- >> The index is reconstituted annually and rebalanced quarterly.

Risk Considerations
