





Dividend Yield is a financial ratio that shows how much a company pays out in dividends each year relative to its share price. Price/Book Ratio is a stock's price divided by its book value, and may help determine if it is valued fairly. P/E Ratio (Trailing) is a stock's price divided by after-tax earnings over a trailing 12-month period, which serves as an indicator of value based on earnings. Total Constituent Daily Traded Value is the sum of the six-month average daily traded value (in USD) of a fund's individual holdings.
