- The index is designed to accurately represent the mega-cap growth segment of the U.S. equity market and deliver low turnover.

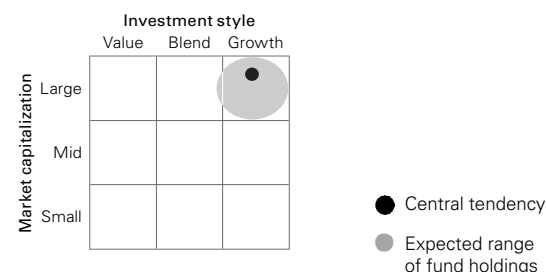

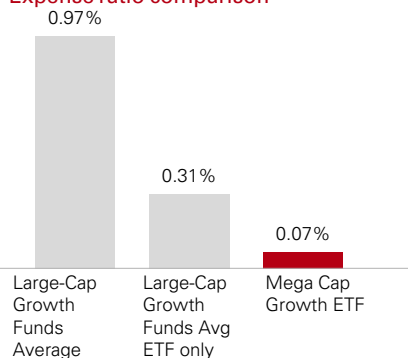
