Alpha: Alpha is a measure of performance on a risk-adjusted basis. Alpha takes the volatility (price risk) of a security or mutual fund and compares its risk-adjusted performance to a benchmark index. The excess return of the security or fund relative to the return of the benchmark index is a fund's alpha. Beta: Beta measures the relationship between the portfolio's benchmark A low beta does not imply that the portfolio has a low level of volatility, rather, a low beta means that the portfolio's benchmark. Downside Capture Ratio: The downside capture ratio measures a manager's performance in down markets relative to a particular benchmark. Information Ratio: The information ratio (IR) measures a portfolio manager's ability to generate excess returns relative to a benchmark, but also attempts to identify the consistency of the portfolio's historical risk-adjusted performance. Tracking Error: Tracking Error: Tracking error measures the standard deviation is a measure of the dispersion of a set of data from its mean. The more spread apart the data, the higher the deviation. Standard deviation is calculated as the square root of variance. Tracking Error: Tracking error measures the standard deviation of the excess returns a portfolio generates compared to its benchmark if a manager tracks a benchmark perfectly, then tracking error will be zero.
