The Fund aims for deep value orientation relative to the Fund benchmark, including low price to earnings, low price to cash flow, and high dividend yield relative to the Fund benchmark. The Fund also aims to manage volatility by selecting stocks whose total returns are expected to fluctuate less than those of the equity markets as a whole.


