



The Weighted Harmonic Average measures the valuation of the portfolio as a whole. For price/book ratio, it is the ratio of the portfolio's total market value in equities to its share of the underlying book value. This method evaluates the entire portfolio like a single stock and it minimizes the impact of outliers.


