» Index Description

- » The Nasdaq US Smart Semiconductor Index™ is a modified factor weighted index created and administered by Nasdaq, Inc. ("Nasdaq") designed to provide exposure to US companies within the semiconductor industry.
- » Nasdaq selects the 30 most liquid eligible semiconductor securities from the NASDAQ US Benchmark Index and then ranks those securities based on three factors:
 - Volatility – trailing 12-month price fluctuation.
 - Value – cash flow to price.
 - Growth – the 3-, 6-, 9-, and 12-month average price appreciation.
- » The securities are weighted based on their score on the three factors.
- » The index weighting methodology includes caps to prevent high concentrations among single stocks.
- » The index is reconstituted annually and rebalanced quarterly.

Additionally, there is no guarantee that vaccines will be effective against emerging variants of the disease.

A fund faces numerous market trading risks, including the potential lack of an active market for fund shares due to a limited number of market makers. Decisions by market makers or authorized participants to reduce their role or step away in times of market stress could inhibit the effectiveness of the arbitrage process in maintaining the relationship between the underlying values of a fund's portfolio securities and a fund's market price.
