
- SPXB's index selects bonds from S&P 500 companies.

"SPXB's total operating expenses are 0.15%. ²Definitions of terms: "30-day SEC yield" is a standard yield calculation developed by the Securities and Exchange Commission that allows investors to more fairly compare funds. The "weighted average maturity" (WAM) of a portfolio is the average time, in years, it takes for the bonds in a bond fund or portfolio to mature. WAM is calculated by weighting each bond's time to maturity by the size of the holding. Portfolios with longer WAMs are generally more sensitive to changes in interest rates. "Effective duration" is a measure of a fund's sensitivity to interest rate changes, reflecting the likely change in bond prices given a small change in yields. Higher duration generally means greater sensitivity. "Returns are based on the composite closing price and do not represent the returns you would receive if you traded shares at other times. The first trading date is typically several days after the fund inception date. Therefore, NAV is used to calculate market returns prior to the first trade date. Index description

S&P 500[®]/MarketAxess[®] Investment Grade Corporate Bond Index

The index selects and weights investment grade bonds based on the following criteria:

- Issued in the United States and denominated in U.S. dollars
- Have a remaining maturity of greater than or equal to one year as of the index's monthly rebalance date
- Have a maturity upon issuance of at least 2.5 years
- Have a minimum par amount of \$750 million

Bonds eligible to be included in the index are ranked based on their liquidity. No more than 1,000 of the most liquid bonds (i.e., those with the highest average trading volumes) are included in the index and weighted by market value. Bond issuances with higher market values are more heavily weighted than bond issuances with lower market values. The index is rebalanced monthly.






