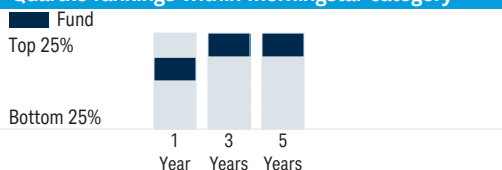

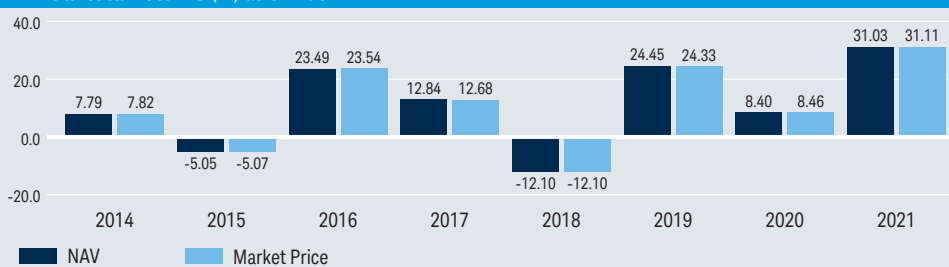
## Quartile rankings within Morningstar category<sup>3</sup>

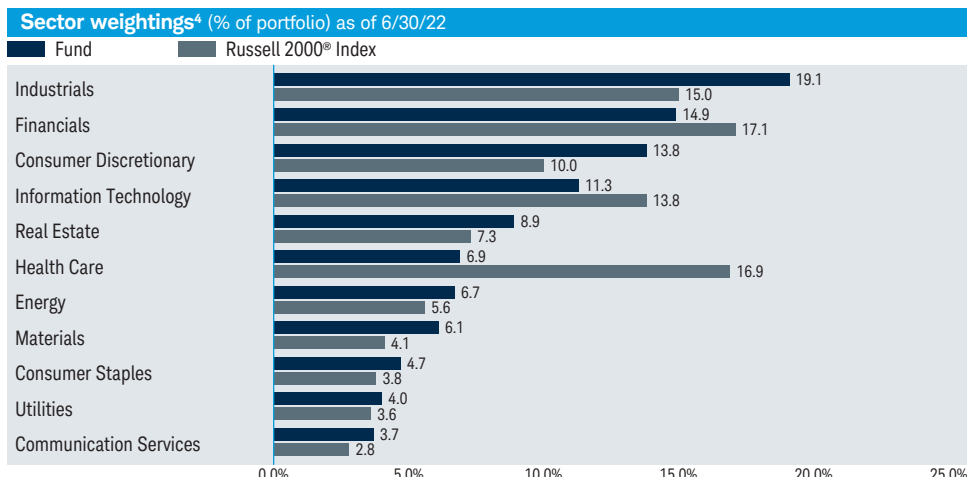
