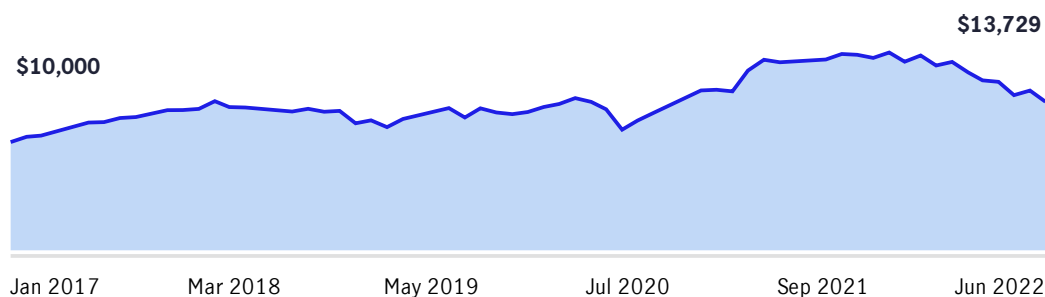

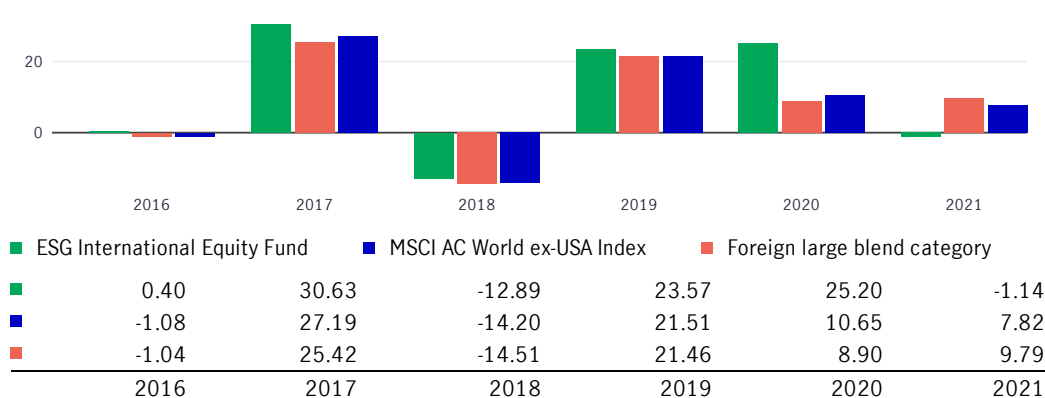
## Growth of a hypothetical \$10,000 investment<sup>4</sup>

A higher Sharpe ratio suggests better risk-adjusted performance. **12** Standard deviation is a statistical measure of the historic volatility of a portfolio. It measures the fluctuation of a fund's periodic returns from the mean or average. The larger the deviation, the larger the standard deviation and the higher the risk. **13** Upside capture ratio measures a manager's performance in up markets relative to the market itself.
