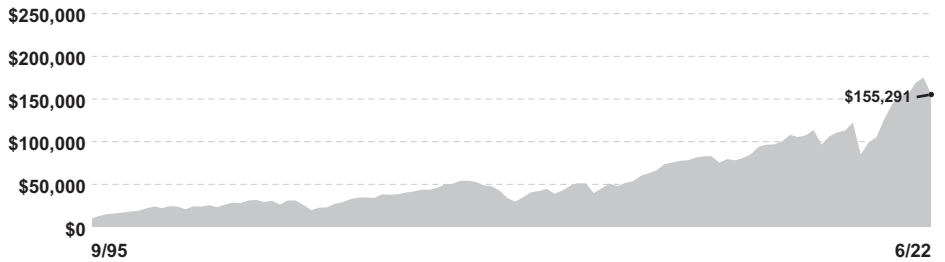

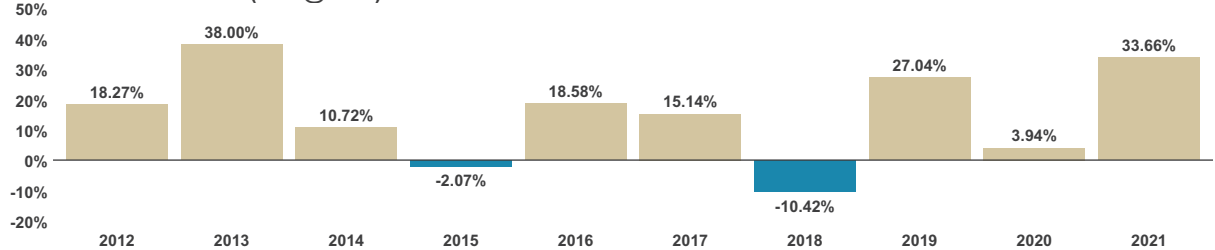

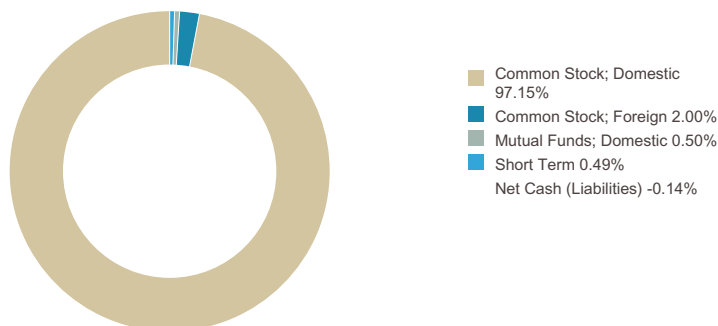

Asset Allocation¹

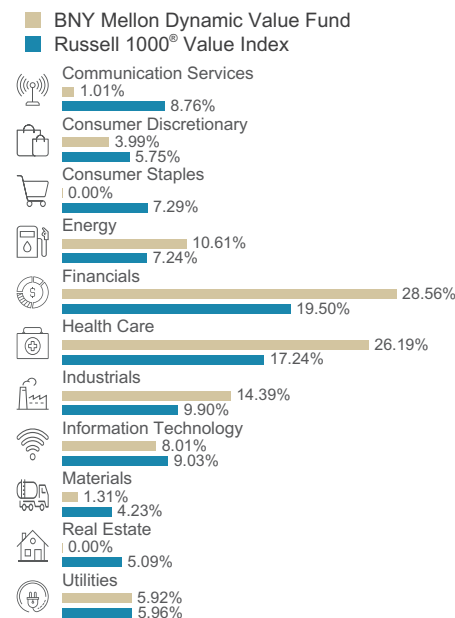

Goal/Approach

The fund seeks capital appreciation. To pursue this goal, the fund normally invests at least 80% of its net assets, plus any borrowings for investment purposes, in stocks. The fund's stock investments may include common stocks, preferred stocks and convertible securities, including those purchased in initial public offerings. The fund may invest up to 30% of its assets in foreign securities.

Portfolio Management

The fund's investment adviser is BNY Mellon Investment Adviser, Inc. (BNYM Investment Adviser). BNYM Investment Adviser has engaged its affiliate, Newton Investment Management North America, LLC (Newton), to serve as the fund's sub-adviser. Brian C. Ferguson, John C. Bailer, CFA, Keith Howell and David S. Intoppa are the fund's primary portfolio managers. Mr. Ferguson has been the fund's lead portfolio manager since September 2003 and is a portfolio manager at Newton. Mr. Bailer has been a primary portfolio manager of the fund since December 2004 and is Deputy Head of Equity Income and a portfolio manager at Newton. Mr. Howell has been a primary portfolio manager of the fund since September 2021 and is a portfolio manager at Newton. Mr. Intoppa has been a primary portfolio manager of the fund since December 2015 and is a research analyst at Newton.
