Fund Overview

The Fund seeks to track the performance of the Calvert US Mid-Cap Core Responsible Index which is composed of common stocks of mid-size companies selected from the 1,000 largest publiclytraded U.S. companies based on market capitalization, excluding approximately the 200 largest publicly-traded U.S. companies. It offers broad exposure to companies that meet The Calvert Principles for Responsible Investment (Calvert Principles).

Research Process

Calvert Research and Management conducts deep, proprietary research across approximately 200 peer groups using over 200 key performance indicators (KPIs) to measure material environmental, social, and governance (ESG) factors. The Calvert US Mid-Cap Core Responsible Index has approximately 600 holdings that are reconstituted annually and are rebalanced quarterly.

Calvert Research and Management is a recognized leader in Responsible Investing, offering investment strategies that seek superior longterm performance and positive global impact. The Calvert Principles provide a framework for considering ESG factors and guide Calvert's active engagement efforts with company management.
