The portfolio management team uses a relative value investment style in an attempt to identify companies with strong financial productivity (as measured by return on equity) at attractive valuations.

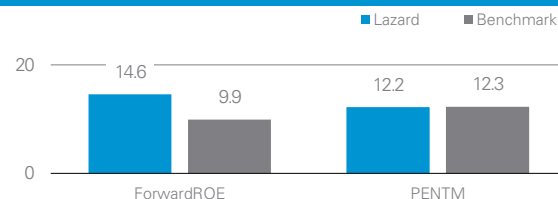
