Fund Highlights¹

- Active management with a long-term, private equity approach to investing; bottom-up stock selection drives excess returns
- Seven-step research framework focuses on quality, growth and valuation; team must view growth as sustainable and profitable
- High-conviction portfolio of typically 30 to 40 stocks; high active share
- Looks to identify high-quality companies – those with difficult-to-replicate business models
- Seeks to create a margin of safety by investing only when company is selling meaningfully below the team's estimate of intrinsic value

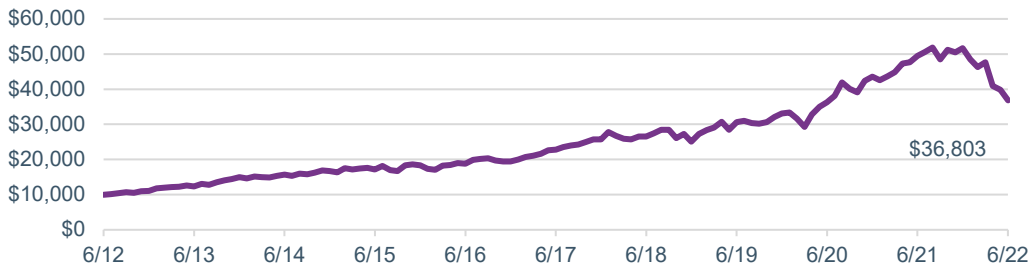

For each fund with at least a three-year history, Morningstar calculates a Morningstar Rating[™] used to rank the fund against other funds in the same category. It is calculated based on a Morningstar Risk-Adjusted Return measure that accounts for variation in a fund's monthly excess performance, without any adjustments for loads (frontend, deferred, or redemption fees), placing more emphasis on downward variations and rewarding consistent performance. Exchange-traded funds and open-ended mutual funds are considered a single population for comparative purposes. The top 10% of funds in each category receive 5 stars, the next 22.5% receive 4 stars, the next 35% receive 3 stars, the next 22.5% receive 2 stars and the bottom 10% receive 1 star (each share class is counted as a fraction of one fund within this scale and rated separately, which may cause slight variations in the distribution percentages). Risks

Cash and Unassigned allocations are not included. ⁶ Beta is calculated for the three-year period and represents the risk associated with the fund relative to market risks. For example, the market has a beta of 1.00, so if a fund has a beta of 0.85, it can be expected to be 15% less volatile than the overall market. Conversely, if a fund has a beta of 1.08, it can be expected to be 8% more volatile than the overall market. ⁷ R-squared is calculated for the three-year period and represents the percentage of the fund's movements that can be explained by the movements of the market. For example, index funds will tend to have R-squared values very close to 100. ⁸ Standard deviation measures the risk of a portfolio or market. Beta, R-squared and standard deviation are calculated on a monthly basis for the three-year annualized period as of the most recent quarter-end. ⁹ Active share indicates the proportion of a portfolio's holdings that are different from the benchmark.
