Began operations: July 30, 1987

Objective: The fund has two primary investment objectives. It seeks (1) to provide a level of current income that exceeds the average yield on U.S. stocks generally and (2) to provide a growing stream of income over the years. The fund's secondary objective is to provide growth of capital.

Distinguishing characteristics: This globally diversified strategy aims to prudently generate a growing stream of income and current income that exceeds the average yield paid by U.S. companies in general. This flexible equity-income strategy uses a mix of stocks and bonds in pursuit of its income objectives, which may have the potential to lead to equity-like returns with relatively less volatility than global markets. Types of investments: Normally, at least 50% of assets will be invested in common stocks of large, established companies with proven records of increasing dividends. May also invest in preferred stocks, convertibles, bonds and cash.

Non-U.S. holdings: May invest up to 50% of assets outside the United States.

Portfolio restrictions: Normally, at least 90% of the fund's portfolio will be invested in income-producing securities.

Implementation guidance: Consider for a global equity-income allocation


