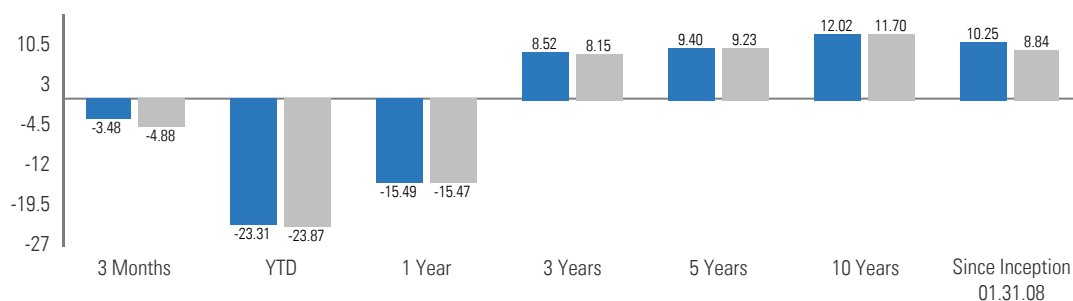

The Net Asset Value (NAV) is the market value of one share of the Fund. The Fund's since inception performance begins at \$10,000, assumes reinvestment of dividends and does not reflect sales charges. Percentages may not sum to 100% due to rounding.

Assets Under Supervision (AUS) includes assets under management and other client assets for which Goldman Sachs does not have full discretion.

Morningstar Risk-Adjusted Ratings: Large Growth Category- Class I Shares 3 Year 4 stars out of 1142 funds, 5 Year 4 stars out of 1060 funds, 10 year 4 stars out of 790 funds. The Morningstar Rating[®] is calculated for funds with at least a 3-year history based on a risk-adjusted return measure that accounts for variation in a fund's monthly excess returns. Exchange-traded funds and open-ended mutual funds are considered a single population.
