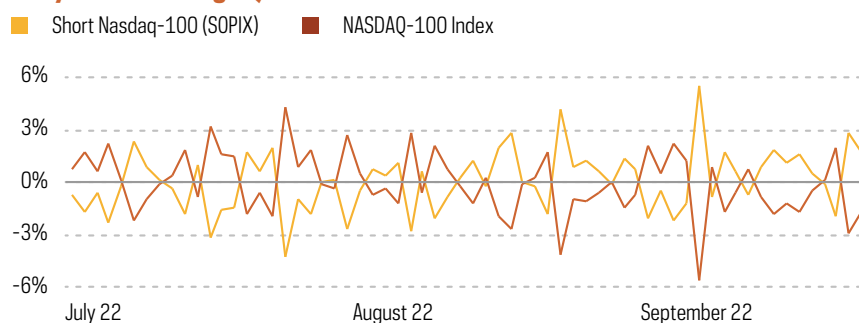

Daily return during 3Q 2022


