- Overweighting a market segment without additional cash

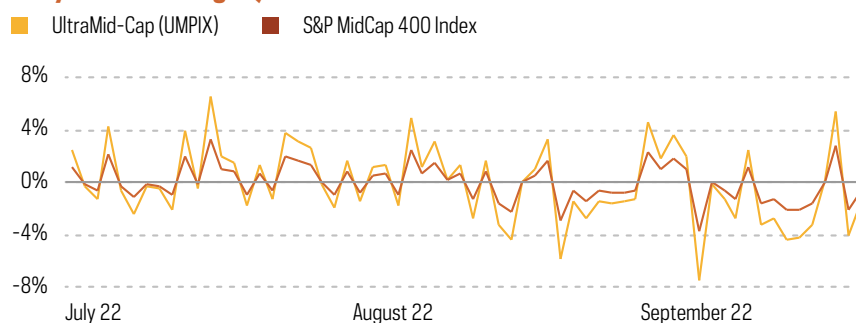

## Daily return during 3Q 2022


