### Philosophy and Process Highlights

We aim to identify long positions that outperform the Russell 1000 Index and short positions that underperform the index. Under our intrinsic value philosophy, we:

- Treat every investment as a partial ownership interest in that company
- Seek to invest at a discount to intrinsic value for long positions and at a premium to intrinsic value for short positions
- Possess a long-term investment temperament
- Recognize that market price and intrinsic value tend to converge over a reasonable period of time

#### **Portfolio Guidelines**


- A long-biased fund with typically 40-60 long positions and 20-45 short positions
- Total long positions are generally between 80-100% of net assets
- Total short positions are generally between 10-40% of net assets

#### **Exposure Guidelines**

- Maximum gross market exposure (long % +  $\frac{\text{short \%)}}{\text{short \%}} = \text{Up to } 140\%$
- Target net market exposure (long % short %) = 40-75%

R-squared represents the percentage of a portfolio's movements that can be explained by general market movements. Up/Down Capture Ratio is used to evaluate how well a portfolio performed relative to an index during periods when that index has risen/dropped.
