- Invests in the lower 80% of companies held within Russell 1000 Index

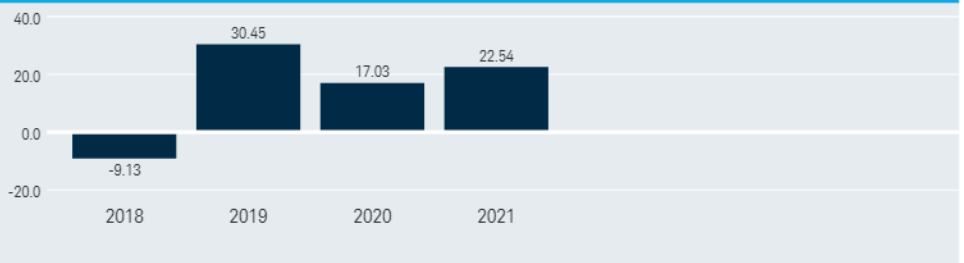

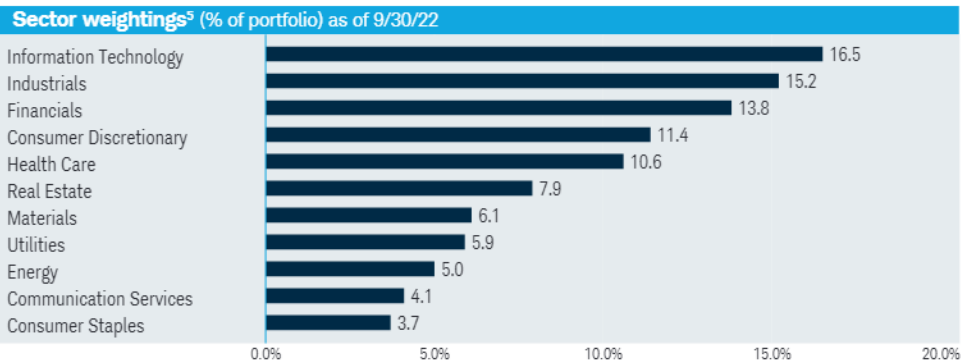
### Quartile rankings within Morningstar category<sup>3</sup>
