Investment objective

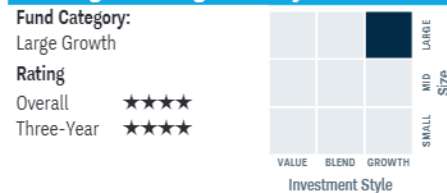
The fund's goal is to track the performance of a benchmark index that measures the total return of large capitalization U.S. growth stocks.

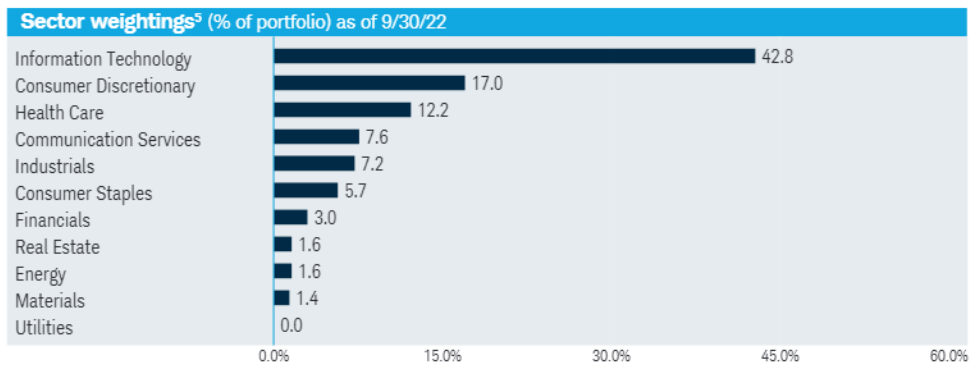
