Fund Highlights and Applications

- Through a combination of an allocation to actively managed individual equity, passive equity, and actively managed fixed income, the fund seeks to exceed the total return of the S&P 500® Index.
- The allocation to actively managed individual equity via stocks, and passive equity via derivatives, is designed to provide exposure to large core equity. Remaining fund assets are invested in actively managed fixed income securities.
- Active and passive decisions seek to add value by tactically allocating to actively managed individual equity when stock picking opportunities are favorable.

Index and Risk Definitions The S&P 500® Index tracks both the capital gains of stocks in the S&P 500 over time, and assumes that any cash distributions, such as dividends, are reinvested back into the index. The S&P 500 Index is a capitalization-weighted index of 500 stocks, actively traded in the U.S., designed to measure the performance of the broad economy, representing major industries. **Trailing P/E ratio** is the weighted average of each individual stock's P/E ratio. The **P/E ratio** of a stock is calculated by dividing the current price of the stock by its trailing 12-month's earnings per share. **Price/Book ratio** is the market price of a stock divided by the book value per share. **Return on equity** is net income divided by net worth. **Three-year EPS growth rate** is a weighted average of each stock holding's growth rate in earnings per share (EPS). EPS is total earnings divided by the number of shares outstanding.
