Fund Highlights^{1,2}

- A low-volatility equity fund that combines an index-like portfolio of underlying equity securities with a
 portfolio of actively managed written index call options
- Consistent and attractive cash flow from index call writing creates potential for better long-term riskadjusted returns than the equity market
- May be used as a component of an equity allocation or an alternatives program seeking equity
 market participation with reduced sensitivity to market swings; the fund is managed to maintain low
 correlation with fixed-income market returns and no significant sensitivity to changes in interest rates
- Fund uses the same investment strategy under all market conditions



If at expiration, the option contract is in-the-money, the seller pays the owner cash in the amount of the difference between the option strike price and the current value of the index; otherwise, the option expires worthless for the buyer and the seller keeps the full premium received up front. The writer of an option is paid a cash premium for taking on the risk associated with the option obligation to pay if the option expires in-the-money. Listed index options contracts can be closed or traded prior to expiration date, but not exercised. 2 Correlation is a statistical measure of how two securities move in relation to each other. 3 The calendar year performance shown for 2014 is a partial year of performance since inception on 9/30/2014 through 12/31/2014.


