

Weighted Avg. Mkt Cap is the average of the market capitalizations of the companies in the portfolio weighted by the size of each company's position within the portfolio. Median Market Cap is the midpoint of market capitalization. Price/Earnings is a stock's per share price divided by its per share earnings over a 12-month period. Active Share is a measure of the percentage of stock holdings in a manager's portfolio that differs from the benchmark index. Turnover is the percentage of a portfolio that is sold in a particular year. Beta is a measure of a fund's sensitivity to market movements. Standard Deviation is a statistical measure of the historical volatility of a fund. Tracking Error is a measure of how closely a fund follows the index to which it is benchmarked. Upside Capture is the statistical measure of an investment manager's overall performance in up-markets.
