
The LSV Global Value Fund's investment objective is long-term growth of capital.

As of September 30, 2022, LSV Global Value Fund (LSVGX, LVAGX) was rated against 156 U.S.-domiciled Global Large-Stock Value funds over a three-year period and 148 funds over a five-year period. With respect to these Global Large-Stock Value funds, LSVGX received ratings of 3 stars over three years and 2 stars over five years.
