Seeks to provide investment results that track the performance of the Nasdaq Victory U.S. Large Cap High Dividend 100 Volatility Weighted Index before fees and expenses.

Nasdaq Victory Volatility Weighting Methodology

Combines fundamental criteria and volatility weighting in an effort to outperform traditional cap-weighted indexing strategies.

About the Index

- Selects the highest 100 dividend-yielding stocks in the Nasdaq Victory US Large Cap 500 Volatility Weighted Index, which first;
 - Screens for profitability—Must have positive net earnings across the last twelve months
 - Selects the largest 500 stocks by market capitalization
- Weights stocks based on risk/volatility (standard deviation over the last 180 trading days)
- Reconstitutes twice a year (March and September)

Why CDL?

- To access some of the highest dividend-yielding, large-cap U.S. stocks that also have positive net earnings across the last twelve months
- For a risk-weighted investment approach that offers broad market exposure

Average Price/Earnings (P/E) Ratio is the current share price of a stock divided by its earnings per share. Market capitalization is the total dollar value of all outstanding shares computed as number of shares times current market price. Market price is the price of the last reported trade on a fund's primary exchange. Net asset value or NAV is a fund's total assets minus its total liabilities, divided by the number of outstanding shares. Premium/discount % indicates whether an ETF is currently trading at a higher or lower price than the current value of the securities in that portfolio. R-squared is a statistical measure that represents the percentage of a fund's or security's movements that can be explained by movements in a benchmark index. Sharpe ratio is the average return earned in excess of the risk-free rate per unit of volatility

or total risk. **Standard deviation** measures an investment's historical volatility, calculated using the investment's annual rate of return. **Subsidized yield** reflects fee waivers/reimbursements/limits in effect. **30 Day SEC yield** is a standard yield calculation developed by the SEC for bond funds. The yield is calculated by dividing the net investment income per share earned during the 30-day period by the maximum offering price per share on the last day of the period. The yield figure reflects the dividends and interest earned during the 30-day period, after the deduction of the fund's expenses. It is sometimes referred to as "SEC 30-Day Yield" or "Standardized Yield."

The Russell 1000® Value Index is a market-capitalization-weighted index that measures the performance of Russell 1000® Index companies with lower price-to-book ratios and lower forecasted growth rates.

Net expense ratio reflects the contractual waiver and/or reimbursement of management fees through October 31, 2022.
