#### **Fund description**

The Fund seeks a favorable long-term total return that reflects the investment performance of the overall foreign equity markets while giving special consideration to certain environmental, social and governance ("ESG") criteria. The Fund's evaluation process favors international companies with leadership in ESG performance relative to their peers. Under normal circumstances, the Fund invests at least 80% of its assets in equity securities of foreign issuers. The Fund attempts to achieve the return of the foreign equity markets, as represented by its benchmark index, the Morgan Stanley Capital International EAFE (Europe, Australasia, Far East) Index (the "MSCI EAFE® Index") while investing in companies whose activities are consistent with the Fund's ESG criteria.

#### **Portfolio management**

Effective 01 May 2022, Darren Tran was added as a portfolio manager on the strategy. This update did not impact the investment strategy.

#### Glossary

Beta is a measure of the volatility of a portfolio relative to the overall market. A beta less than 1.0 indicates lower risk than the market, **P/E ratio** of a stock is calculated by dividing the current price of the stock by its forecasted 12 months' earnings per share. The average of the price/earnings ratio of a fund is a weighted harmonic average of all the current P/E ratios (excluding negatives) of the stocks in the Fund's portfolio. Standard deviation is a statistical measure of the historical volatility of a mutual fund or portfolio; the higher the number the greater the risk. Turnover ratio is calculated by dividing the lesser of purchases or sales by the average value of portfolio assets during a period. Weighted average market capitalization is the portfolio-weighted mean capitalizations of all equity securities.
